A valid permit receives an approved inspection every 180 days. Work sha be considered not suspended, abandoned or invaid when the permit has received an approved inspection within 180 days of the previous approved inspection.

FLORIDA'S CONSTRUCTION LIEN LAW: Protect Yourself and Your Investment: According to F orida Law, those who work on your property or provide materias, and are not paid in fu, have a right to enforce their caim for payment against your property. This caim is known as a construction ien f your contractor fais to pay subcontractors or materia suppliers or neglects to make other egally yrequired payments, the people who are owed money may look to your property for payment, even if you have paid your contractor in fu. This means if a lien is fill ed against your property, it could be sold against your will to pay for abor, materials or other services which your contractor may have failed to pay
