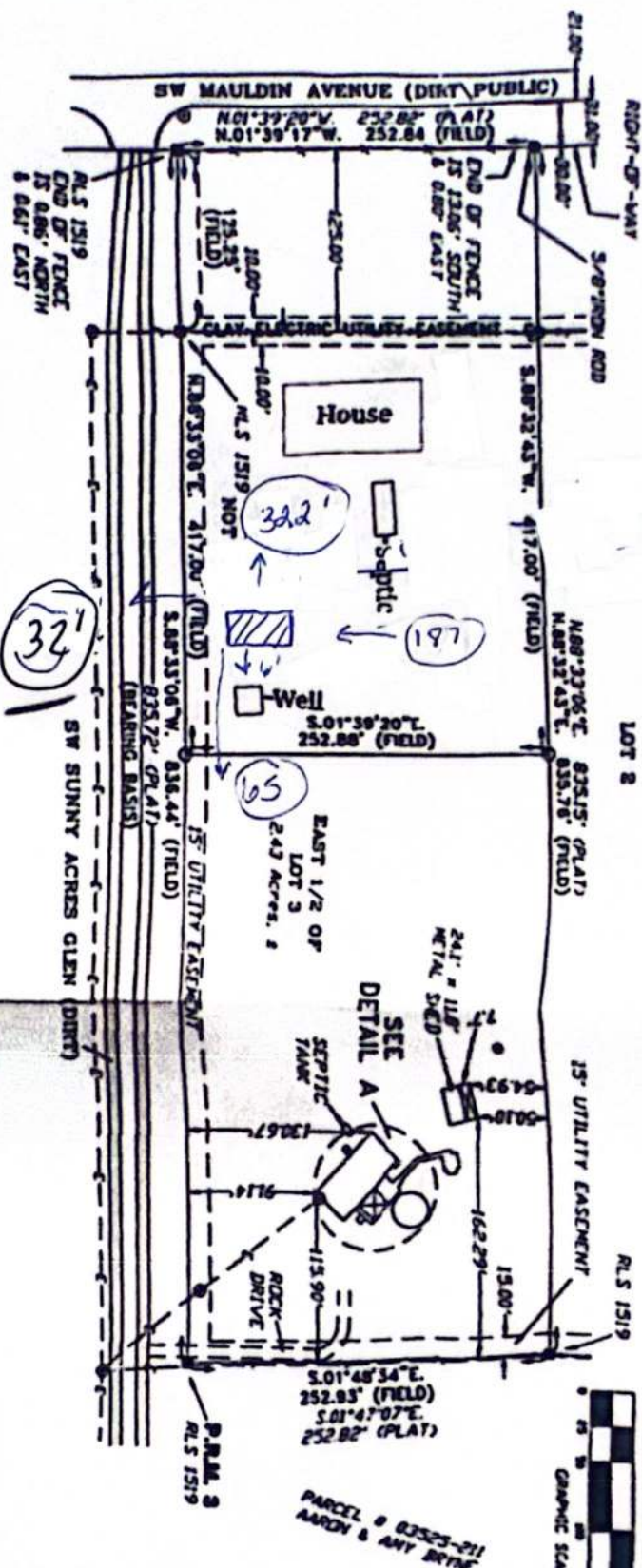


BOUNDARY SURVEY IN SECTION 10, TOWNSHIP 16 EAST,
