





A part of Section 24, Township 5 South, Range 15 East, Columbia County, Florida described as follows: commence at the NE corner of said Section 24, Township 5 South, Range 15 East, Columbia County, Florida and run thence S.01°25'36"E., along the East line of said Section 24 a distance of 2304.74 feet; thence S.88°01'22"W., distance of 40.27 feet to the West right-of-way line of SW Ichetucknee Avenue; thence continue S.88°01'22"W., a distance of 502.90 feet to the POINT OF BEGINNING; thence continue S.88°01'22"W., a distance of 743.95 feet to the East right-of-way line of SW Joe Markham Drive; thence along the East right-of-way line of said Joe Markham Drive the following calls: S.01°21'15"E., a distance of 422.80 feet to a point of curve to the right having a radius of 330.00 feet and an internal angle of 14°50'08"; thence run Southerly along the arc of said curve a distance of 85.45 feet to the point of tangency; thence S.13°28'54"W., a distance of 97.15 feet; thence S.01°28'45"E., along said West line of the East 1/2 of the NE 1/4 a distance of 29.26 feet to its intersection with the Easterly right-of-way line of SW Joe Markham Road and point of curve to the left having a radius of 70.00 feet and an internal angle of 65°18'59"; thence run Southerly and Easterly along the arc of said curve a distance of 79.80 feet to the point of tangency, said curve being subtended by a chord bearing and distance of S.46°02'30"E., 75.55 feet; thence S.78°41'59"E., distance of 38.23 feet to a point of curve to the right having a radius of 330.00 feet and an internal angle of 10°58'22"; thence run Easterly along the arc of said curve a distance of 63.20 feet to the point of tangency; thence S.67°43'38"E., distance of 175.59 feet to a point of curve to the left having a radius of 270.00 feet and an internal angle of 17°36'20"; thence run Easterly along the arc of said curve a distance of 82.96 feet to the point of tangency; thence S.85°19'58"E., distance of 311.85 feet to a point of curve to the left having a radius of 470.00 feet and an internal angle of 02°43'47"; thence run easterly along the arc of said curve a distance of 22.39 feet to the point of tangency; thence S.88°03'45"E., distance of 56.21 feet; thence N.01°21'15"W., leaving said South right-of-way line of SW Joe Markham Drive a distance of 849.57 feet to the POINT OF BEGINNING.
