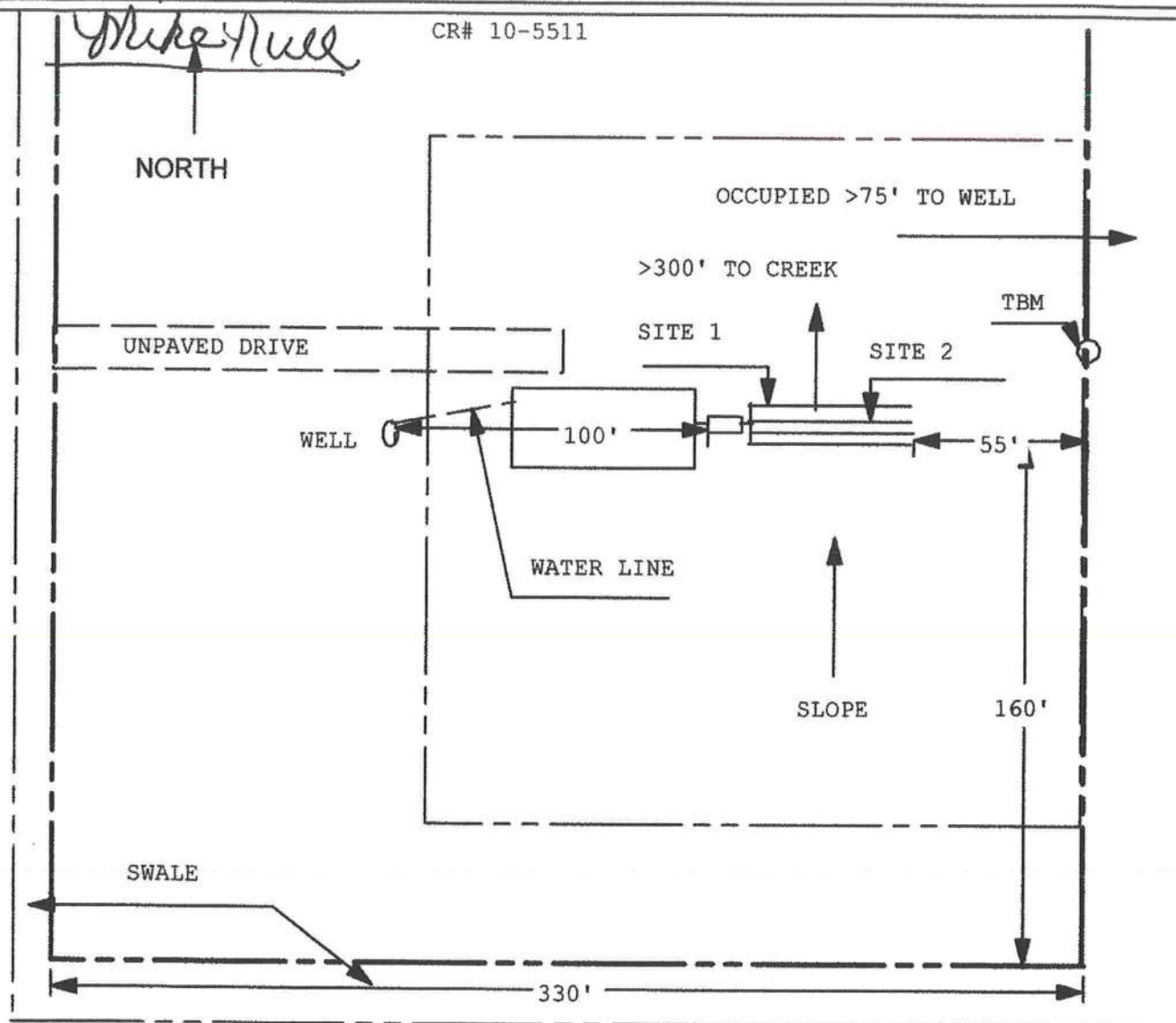

FLOOD DISCLOSURE STATEMENT

Owner has made application to COLUMBIA COUNTY, FLORIDA for a building permit for the property affected by Tropical Storm Debby where the existing dwelling is located in Zone A according to the 2009 FEMA Flood Insurance Maps for moving the existing dwelling to a different location on the same property not affected by flooding.

Owner is aware that although the proposed location where the existing dwelling is being moved to on the property is not located in a special flood hazard area as designated by the 2009 FEMA Flood Insurance Rate Maps, the property has flooded in the past and may be subject to flooding in the future. The Owner has been advised to review all available flood data, including 2012 aerial photographs or other available flood maps in making the decision to proceed with the building permit. Owner is aware that such natural flooding may occur in the future.

COLUMBIA COUNTY, FLORIDA is issuing a building permit at the Owner's request, but makes no representations to Owner whether the property will or will not be subject to future flooding conditions resulting in damages to Owner's dwelling or other improvements on the property. Owner will record this Flood Disclosure Statement in the public records of Columbia County, Florida
