FEMA is committed to assisting you with your ongoing disaster recovery. This letter explains how to request additional rental assistance from FEMA.

We expect all families who receive FEMA temporary rental assistance to return to their damaged home when it is repaired or to locate and occupy affordable housing without FEMA rental assistance at the earliest possible time. However, we realize that some families may need additional FEMA rental assistance to help achieve that goal.

If you require additional FEMA rental assistance, the enclosed Declaration of Continuing Need for Temporary Rental Assistance will assist us in processing your request. You must complete the full Declaration of Continuing Need for Temporary Rental Assistance each time you request additional rental assistance.

To make sure that you receive additional rental assistance as quickly as possible, you must read the attached Declaration of Continuing Need for Temporary Rental Assistance carefully and fill it out completely. You must submit it to us within 10 days of receiving this letter in order to receive your rent in a timely manner. Keep a copy for your records.

If you do not contact us within 90 days of the date of this letter to express your continued need, you will not be eligible for additional rental assistance. If the FEMA disaster period ends within this 90 day period, you will be required to have all required documentation submitted prior to the closure date.
