
DESCRIPTION

BEGIN AT THE SOUTHWEST CORNER OF THE N.W. 1/4 OF THE S.W. 1/4, SECTION 20, T.W.S. 3-SOUTH, RANGE 17-EAST, COLUMBIA COUNTY, FLORIDA AND RUN N. 21° 5' W. ALONG THE WEST LINE OF SAID SECTION 20, 1048 FEET TO THE SOUTHWEST RIGHT OF WAY LINE OF U.S. HIGHWAY NO. 41, THENCE S. 42° E. ALONG SAID RIGHT OF WAY LINE 1258.96 FEET THENCE S. 48° W. 119.2 FEET TO A POINT ON THE SOUTH LINE OF SAID N.W. 1/4 OF S.W. 1/4, THENCE S. 87° 29' W. 715.10 FEET TO POINT OF BEGINNING.
