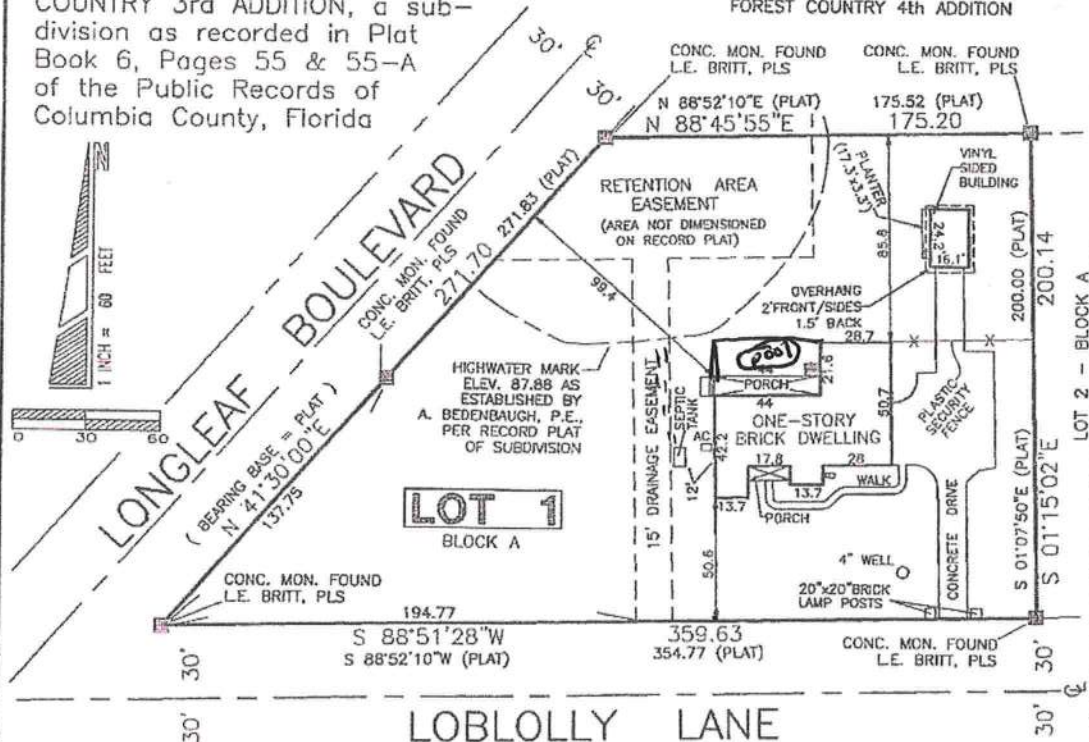


BOUNDARY SURVEY
