**W I T N E S S E T H:**

That the Grantor, pursuant to the powers granted under the Trust, and in consideration of the sum of **TEN AND NO/100 (\$10.00) DOLLARS**, and other good and valuable considerations in hand paid, grants, bargains, aliens, remises, releases, conveys and confirms to the Grantee, and the Grantee's heirs, personal representatives, successors, and assigns forever that certain real property situate in Columbia County, Florida, more particularly described as follows:

The undersigned hereby swears, affirms, and warrants that **IDELL VINZANT PONDS** died in August 2015, and that at the time of her death she was an unmarried widow and had no minor children.

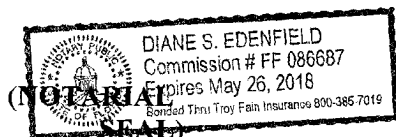
