In accordance with your request, we have performed an inspection at the above referenced residence. The purpose of the inspection was to determine the need for structural repairs to the residence as a result of damage caused by a fire which started on the outside of the residence near the dining room.

The residence is a single story wood frame structure with a vinyl siding over shiplap siding, see Photo 1. The structural damage noted, consisted of damage to the floor framing, siding, and wall framing on the north side of the residence near the dining room, see Photo 2. Some minor damage to interior finishes was noted in the north wall of the dining and living rooms, see Photos 3 and 4.




Photo 2 - Fire Damage North Wall




Photo 3 – N. Wall of Dinning Room.

In order to restore the residence to its pre-damaged condition, we recommend the following repairs be made.


- 1. Shore existing floor joist in area of fire damage. Remove and replace 12 linear feet of fire damaged existing double 2x8 joist support beam. Provide additional 8x8x16 block support at mid span.
- 2. Remove and replace 20 linear feet of double 2x10 floor joists damaged by fire.
- Remove and replace 20 linear feet of fire damaged 2x8 rim board.
- 4. Remove and replace 18 linear feet of damaged 2x4 base plate.
- 5. Replace burned 2x4 stud in dining room north wall.
- 6. Replace damaged wood lap siding with 3/4" exterior plywood sheathing and nail with 10d nails at 6" on center edges and 12" field.
- 7. Replace vinyl siding on exterior north wall to match existing.

If additional structural damage is found during the repair process that was not covered in this report, please notify our office so that we may further evaluate the need for additional repairs. If you have any questions please do not hesitate to contact our office.
