Trust Agreement made this day of 2019, between BETTY J. BOUTWELL and JAMES M. BOUTWELL, jointly referre to as Settlors, and BETTY J. PALMER (awa B.J. PALMER), referred to as Trustee.

In consideration of the mutual covenants and promises set forth herein, Settlors and Trustee agree:

L TRUST ESTATE:

In consideration of the acceptance by the Trustee of the trust created herein, and other good and valuable consideration, the receipt of which is hereby acknowledged, The Settlors hereby deliver to the Trustee as the initial principal of the trust the sum of Ten Dollars (\$10.00).

2. DISTRIBUTION OF INCOME AND PRINCIPAL:

Trustee shall hold, manage, invest and reinvest the trust estate in the manner herein provided, shall collect the income thereof, and shall dispose of the net income and principal as follows:

- A. During the joint lifetimes of Settlors, Trustee shall pay any or all net income of the trust to Settlors upon request in writing from the Settlors to the Trustee;
- B. On the death of either Settlor, any or all net income shall be paid, upon written request, to the survivor during the survivor's lifetime; provided, however, that if at any time both Settlors are unable to manage their own affairs, the successor Trustee may use such sums from income and/or principal of the trust estate as the Trustee deems necessary or advisable for the support, maintenance and medical care of the Settlors or for any other purposes the successor Trustee consider to be for the Settlor's best interest, adding to principal any income not so used. The Trustee may rely upon written notice from Settlors' physician as to their ability to manage their own affairs.
- c. In addition to the net income, Trustee is authorized, at the request of either Settlor, at any time and from time to time, to pay or apply from the principal of the trust (even to the point of completely exhausting the same), such amounts as may be necessary for the health,

15. BENEFICIAL INTEREST

A. The Settlors shall have the right to reside upon any real property placed in this Trust as their permanent residence during their life. It is the intent of this provision to grant to the Settlors the requisite beneficial interest and possessory right in and to such real property to comply with Section 196.041 of the Florida Statutes; such beneficial interest and possessory rights constitutes in all aspects "equitable title to real estate" as that term is used in Section 6, Article VII of the Constitution of the State of Florida (Homestead Tax Exemption). Notwithstanding anything in this Trust Agreement to the contrary, the interest of the Settlors in any real property upon which Settlors reside pursuant to the provisions of this Trust Agreement shall be deemed to be an interest in real property, and not pérsonalty. This provision does not restrict the Trustee(s) from selling, leasing, or encumbering that property without the Settlors' joinder in any deed or instrument.

16. CONSTRUCTION OF AGREEMENT:

The headings and subheadings used throughout this Agreement are for convenience only and have no significance in the interpretation of the body of this Agreement, and Settlor directs that they be disregarded in construing the provisions of this Agreement.


