## General Warranty Deed

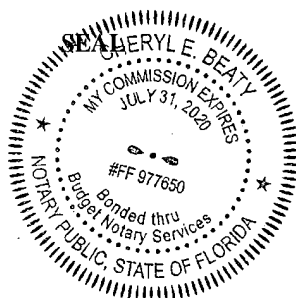
