## DESCRIPTION:

THE E1/2 OF THE NE1/4, SECTION 25, TOWNSHIP 4 SOUTH, RANGE 16 EAST, AS LIES SOUTH OF STATE ROAD NO. 5-242, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCE AT THE NORTHEAST CORNER OF THE SE1/4 OF THE NE1/4, SECTION 25, TOWNSHIP 4 SOUTH, RANGE 16 EAST, AND RUN THENCE,  $50^{\circ}30'W$ , ALONG THE EAST LINE OF SAID SECTION 25, 44.15 FEET, TO THE SOUTH LINE OF STATE ROAD NO. 5-242, FOR A POINT OF BEGINNING, THENCE CONTINUE  $50^{\circ}30'W$ , ALONG SAID EAST LINE OF SECTION 25, 1276.16 FEET, TO THE SOUTHEAST CORNER OF SAID SE1/4 OF NE1/4, THENCE RUN  $S86^{\circ}21'30"W$ , ALONG THE SOUTH LINE OF SAID SE1/4 OF NE1/4, 1161.12 FEET, TO THE SOUTHWEST CORNER OF SAID SE1/4 OF NE1/4, THENCE RUN  $N0^{\circ}02'30"W$ , ALONG SAID WEST LINE OF SE1/4 OF NE1/4 1328.33 FEET, TO SAID SOUTH LINE OF STATE ROAD NO. 5-242, THENCE RUN  $N88^{\circ}56'30"E$ , ALONG SAID SOUTH LINE OF STATE ROAD NO. 5-242, 722.20 FEET, TO A POINT OF CURVE, THENCE RUN ON A CHORD BEARING OF  $N88^{\circ}50'E$ , A CHORD DISTANCE OF 449.07 FEET, TO THE POINT OF BEGINNING. SAID LAND LYING IN THE E1/2 OF THE NE1/4, SECTION 25, TOWNSHIP 4 SOUTH, RANGE 16 EAST, COLUMBIA COUNTY, FLORIDA, AND CONTAINING 34.85 ACRES MORE OR LESS.
