A valid permit receives an approved inspection every 180 days, Work shall be considered not suspended, abandoned or invalid when the permit this received an approved inspection within 180 days of the previous approved inspection.

FLORIDA'S CONSTRUCTION LIEN LAW; Protect Yourself and Your Investment; According to Florida Law, those who work on your property or provide materials, and are not pald-in-full, have a right to enforce their claim for payment against your property. This claim is known as a construction lien. If your contractor falls to pay subcontractors or material suppliers or neglects to make other legally required payments, the people who are owed money may took to your property for payment, even if you have paid your contractor in full. This means if a lien is filed against your property, it could be sold against your will to pay for labor, materials or other services which your contractor may have falled to pay.

A NOTICE OF COMMENCEMENT MUST BE RECORDED AND POSTED ON THE JOB SITE BEFORE THE FIRST INSPECTION.
