

EXHIBIT "A"

(Legal Description)

Commence at the southwest corner of the southeast quarter of the southwest quarter of Section 32, Township 3 South, Range 17 east, Columbia County, Florida, and run thence north 88 degrees 05 minutes east 70.8 feet to an old iron pipe at the edge of a walkway for the POINT OF BEGINNING. From said POINT OF BEGINNING run north 02 degrees 29 minutes 57 seconds east 190.65 feet to an "X" in the top of a curb; thence north 84 degrees 48 minutes 15 seconds east 46.02 feet to an old iron pipe; thence south 74 degrees 32 minutes 04 seconds east 30.69 feet to a concrete monument (W.C. Hale); thence north 89 degrees 43 minutes 15 seconds east 374.01 feet to a concrete monument on the westerly boundary of Mrs. Sanders Addition, a Subdivision as per map or plat thereof recorded in Plat Book 1, page 46 of the Public Records of Columbia County, Florida; thence south 00 degrees 47 minutes 00 seconds east (bearing base from deed) along said westerly boundary 474.99 feet to a concrete monument; thence south 87 degrees 37 minutes 50 seconds west along the northerly boundary of property described in Deed Book 66, page 131 of the Public Records of Columbia County, Florida, a distance of 127.83 feet to a concrete monument (W.C. Hale); thence south 06 degrees 48 minutes 54 seconds west along the westerly boundary of said property 111.95 feet to an old 1-1/2" iron pipe; thence south 86 degrees 55 minutes 27 seconds west 19.93 feet to a concrete monument; thence south 06 degrees 49 minutes 24 seconds west 166.95 feet to a concrete monument on the northerly right of way boundary of Arredonda Street (50 foot right of way); thence south 87 degrees 27 minutes 05 seconds west along said northerly right of way boundary 169.97 feet to an old 1-1/2" iron pipe on the easterly boundary of property described in Official Records Book 399, pages 408-410 of the Public Records of Columbia County, Florida; thence north 00 degrees 01 minute 00 seconds west along said easterly boundary 161.83 feet to an old 1-1/2" iron pipe; thence south 87 degrees 07 minutes 49 seconds west along the northerly boundary of said property 141.17 feet to an iron pin on the easterly right of way boundary of State Road No. 25 (First Street) (100 foot right of way); thence northerly along said easterly right of way boundary run north 04 degrees 50 minutes 35 seconds east 113.72 feet; thence north 03 degrees 16 minutes 53 seconds east 309.85 feet to the POINT OF BEGINNING; containing 294,519 sq. ft. or 6.76 acres, more or less.
