WHEREAS the parties have received approval for a planned rural residential development of such property; and

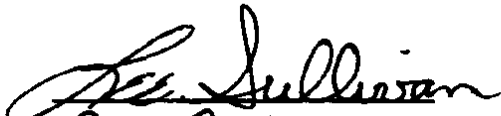

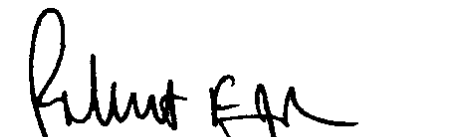
NOW THEREFORE it is agreed as follows:

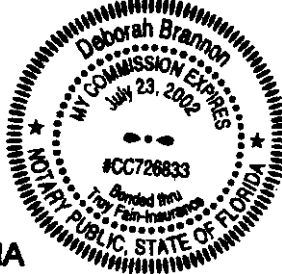
