Melissa,

I'm helping Mr. Laskey with his permitting. I've attached new truss engineering to this email. I think the seal is clearer. As for the scopes. The truss repair is really the only scope under this permit. However, there will be some incidental work that will need to be done due to the repair of the trusses. After the truss repairs Mr. Laskey will need to install a new roof, repair some exterior walls, drywall the ceilings, and paint the interior. It is a bit dangerous to get into his attic to investigate further what may need to be done. After the damaged roof system is removed, he will have a better idea of what needs to be done. We've estimated the repairs and new roof around \$40,000.
