## SPECIAL WARRANTY DEED

Part of the Southeast 1/4 of the Northeast 1/4 of Section 27, Township 4 South, Range 16 East, Columbia County, Florida and being part of Lot 3, Block A of TIMUCUAN CROSSING, a subdivision as per plat thereof recorded in Plat Book 6, Pages 191 and 192 of the Public Records of Columbia County, Florida, more particularly described as follows:

COMMENCE at the Northwest corner of said Southeast 1/4 of the Northeast 1/4 and thence run South 02 degrees 37 minutes 23 seconds East, along the West line of said Southeast 1/4 of the Northeast 1/4, a distance of 956.41 feet to the POINT OF BEGINNING; thence North 87 degrees 51 minutes 50 seconds East, 786.17 feet to a point on the Right-of-Way line of Southwest Dyal Avenue, (a 60 foot wide public Right-of-Way); thence South 28 degrees 35 minutes 28 seconds West, along said West Right-of-Way line, 443.28 feet to the South line of said Southeast 1/4 of Northeast 1/4; thence South 88 degrees 00 minutes 41 seconds West, 556.45 feet to the Southwest corner of said Southeast 1/4 of Northeast 1/4; thence North 02 degrees 37 minutes 23 seconds West, 379.62 feet to the POINT OF BEGINNING.
