FIRST AMENDMENT TO THE

GREEN FAMILY REVOCABLE TRUST AGREEMENT

WHEREAS, the Settlors and Trustees, BILLY R. GREEN and INGRID M. GREEN, entered into that GREEN FAMILY REVOCABLE TRUST AGREEMENT on June 6, 2017, which Trust Agreement is specifically amendable in whole or in part, according to its terms; and

WHEREAS, BILLY R. GREEN and INGRID M. GREEN, as Settlors, desire to amend said Trust Agreement through the medium of this Amended Trust;

NOW THEREFORE, the GREEN FAMILY REVOCABLE TRUST AGREEMENT dated June 6, 2017, is hereby amended pursuant to Article III, as follows:

ITEM I

BILLY R. GREEN and INGRID M. GREEN, as equal Settlors and Trustees, appoint their daughter, DEBRA HENRICH, to act individually or jointly with the Settlors as Co-Trustee of the GREEN FAMILY REVOCABLE TRUST AGREEMENT dated June 6, 2017.

The signature of any Trustee shall be sufficient to deposit funds, make withdrawals, execute any bill of sale, certificate of ownership, deed or any other documents or instruments which are required to be executed in order to carry out the intent and purpose of the Trust.

Settlors maintain the sole and absolute authority to (i) amend, alter, modify or change this Trust Agreement in any manner; and/or (ii) change the Co-Trustee or Successor Trustee or Successor Trustees: and/or (iii) withdraw any part or all of the properties contained in the Trust; and/or (iv) revoke or terminate this Trust Agreement, in part or in whole, in which latter event any and all Trust properties shall forthwith revert to the Settlor as his own property free of Trust, by an instrument in writing, signed by the Settlors and delivered to the Co-Trustee.

ITEM II

Article VI, is hereby amended and replaced in its entirety to provide as follows:

ARTICLE VI

1. After the resignation, death or inability to manage the affairs of a Co-Trustee, the

remaining Trustees shall shall continue to serve as Co-Successor Trustees.

2. After the resignation, death or inability to manage affairs of all Trustees, the Settlors

appoint their granddaughter. JESSICA VAIL, to act as Successor Trustee.

3. All Successor Trustees shall have the same powers given the original Trustees and shall

serve without bond or security. No Successor Trustee shall be liable for any act or omission of any

predecessor and may accept the property received, without a prior accounting, without incurring any

liability for doing so.

4. The term "Trustee" refers to the single, multiple and Successor Trustees who at any time

may be appointed and may act in a fiduciary capacity under the terms of this Agreement.

ITEM III

In all other respects, Settlors, BILLY R. GREEN and INGRID M. GREEN, confirm the Trust

Agreement dated June 6, 2017, reserving the right to further amend or revoke the same and this

Amendment thereto.
