Staff Comments- Assistant County Manager Kevin Kirby made a comment about bad dogs and animal control business by the County. County will capture the animals and turn them over to the Humane Society. Humane Society and the County does not have anymore room due to a business model change by the Humane Society.

Discussion ensued about business model of the Humane Society. County Attorney, Joel Foreman added input. Does County need a pound facility?

Discussion ensued about the issue.

Chairman, Timothy Murphy directed County Attorney Joel Foreman to work on the costs of a pound and funding. The Humane Society to work on a solution to the problem of no room for all dogs that need to be picked up.

County Commissioner, Rocky Ford wanted to give an update to the board about the meeting with Suwannee County on the landfill and what was decided.

County Attorney, Joel Foreman responded and wanted to make the board was aware on what happened in the meeting and this is Commissioner Kevin Parnell's area.

Discussion ensued about the issue.

Assistant County Manager, Kevin Kirby added input about the landfill expansion. He also stated that he thought it was a productive meeting.

Commissioner, Kevin Parnell responded that he wants to make sure that Columbia County is taken care before we take care of other counties.

Chairman, Timothy Murphy responded.

County Commissioner, Rocky Ford gave an update about the septic tank issue that was challenged in court. It is no longer an issue.

Chairman, Timothy Murphy asked what is the plan in 2026 for the plant in Ellisville for regards to sewer. County Manager, David Kraus responded.

County Commissioner, Robbie Hollingsworth added that the community needs to be aware of the septic tank issues.

County Manager, David Kraus responded about the plan for 2026 in regards to the sewer. County Commissioner, Rocky Ford and County Commissioner Robby Hollingsworth asked about someone from the County Health Department coming to the meeting.

Discussion was ensued.

County Commissioner, Kevin Parnell asked about a trampoline park coming to the County? County Commissioner, Rocky Ford and County Commissioner, Robbie Hollingsworth stated they did not agree to give property to the investor of the trampoline park. County Attorney, Joel Foreman stated that it is not unusual for the BOCC to know until further in the process.
