RE: Marcotek/Xerox copier leases

Over the past several years we have engaged leasing contracts exclusively with Marcotek for Xerox copiers and multifunction devices. Due to Xerox corporate restructuring Saxon Business Systems has taken over as the preferred provider for Xerox which is based out of Jacksonville.

We have had issues with Xerox hardware, software and firmware on multiple occasions in the past. Xerox is not compatible with our DMS software application *(Microsoft SharePoint)* without the need for costly 3rd party servers, software annual maintenance fees as well as customer service delays.

Due to Xerox's equipment issues, lack of compatibility and no local vendor support, I would like to recommend we use McCrimmons as our local vendor and utilize Sharp copiers and multifunction devices standard for all departments. All Sharp devices meet or exceed our needs, out performs Xerox and is directly compatible with Microsoft SharePoint. McCrimmons is the State of Florida preferred vendor for Sharp devices and uses state contract pricing.

We have four Xerox copiers with expired leases, 911 Dispatch, Public Library, Solid Waste and Addressing that I would like to replace with Sharp devices. Switching to Sharp has annual cost saving benefits, increased compatibility and we own the equipment at the end of the lease.

I have attached price quotes for the four departments as well as a cost comparison for your review. If you have any questions please let me know.
