COLUMBIA COUNTY, FLORIDA RESOLUTION NUMBER 2021R-35

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS FOR COLUMBIA COUNTY, FLORIDA, EXPRESSING SUPPORT FOR SWEETWATER APARTMENTS, PHASE II, A PROPOSED AFFORDABLE HOUSING PROJECT

WHEREAS, the Board of County Commissioners received a presentation on September 2, 2021 outlining a proposed affordable housing project known as "Sweetwater Apartments, Phase II", an 84-unit complex proposed for construction on approximately 6.5 acres with frontage on Martin Luther King Street and Davis Avenue in Lake City, Florida (the "project");

WHEREAS, as part of that presentation, Lake City Community Development Corporation, Inc., (the "Developer") requested a statement reflecting the County Commission's support for the construction of the project in Columbia County;

WHEREAS, the Developer further requested that the County Commission commit to loan three million dollars (\$3,000,000.00) to be used in the construction of the project on terms set forth in an August 11, 2021 written request to the County Manager; and

WHEREAS, the Board of County Commissioners wishes to express its support for the construction of the project and make known its willingness to further consider the loan as requested, but subject to a separately negotiated agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF COLUMBIA COUNTY, FLORIDA, AS FOLLOWS

- 1. The recitals above are true and correct and are incorporated herein.
- 2. The Board of County Commissioners for Columbia County, Florida hereby formally expresses its support for the construction of the project as described in the proposal made on September 2, 2021, and the Board of County Commissioners expresses its agreement with the Developer that increased and improved affordable housing is needed in Columbia County.
- 3. The Board of County Commissioners directs the County Manager and staff to negotiate terms of any proposed loan or other incentive from the County to the Developer for the construction of the project, and the Board will further consider any such negotiated arrangement if the same is approved for legal sufficiency by the County Attorney.
- 4. This resolution shall in no event be construed to obligate the County to make any loan of paty any incentive in connection with the project. This resolution shall not be construed as a promise or guarantee of any kind with respect to any financial or other obligation of the County with respect to the project. Any decision to offer financial support of any kind for the project shall be made only in the discretion of and with a majority vote of the Board of County Commissioners, all of which shall occur in a regular or special session of the Board.

Affordable Housing Opportunity

To whom it may concern,

It has been brought to my attention there is a possible opportunity for new affordable housing in our area. On behalf of the Christian Service Center and the neighbors we serve, I can confidently affirm there is an essential need for this in our community. Over the past few years, we have not only experienced growth in our community, but we have also seen a drastic increase in homelessness and a decrease in housing opportunities for lower income families. We attribute this to a lack of availability in the local housing market, including both viable rental and homeowner properties.

On average, we have perpetually received close to 15 to 20 calls per week about homelessness or families in need of housing and several individuals stopping by for help or information. We also have countless conversations during our interviews with individuals facing eviction or seeking suitable, affordable, and sustainable housing. This year alone we have already reach 54% of the homeless assistance totals that we ended the 2021 year with and that number continues to climb exponentially. Our neighbors we were meeting merely a couple of years ago for occasional needs are now struggling to keep a roof over their family's head or have already lost their homes to distressed circumstances.

As Lake City continues to grow and flourish, we must also remember our neighbors that might be struggling in the conditions or circumstances they are living through. Our national poverty rate is currently over 14% nationwide and that number seems to be unfortunately fluctuating. The opportunity for much needed affordable housing in our community could be beneficial to many individuals and families in our area.

Dear Commissioners,

United Way of Suwannee Valley is writing this letter to express the need for more affordable housing in our area. As a city, we are facing a housing affordability crisis, and one of the most important actions we can take to address that crisis is to build more affordable homes.

United Way of Suwannee Valley received the Emergency Solutions Grant CV dollars through the CARES Act funding. During the past year, United Way of Suwannee Valley fielded over 58,000 calls, provided assistance for 105 families to remain housed and housed over 184 households (367 total individuals housed) with these funds alone. The 2021 eviction moratorium really emphasized the need for affordable housing for this area. A substantial increase in local rent in response to the eviction moratorium has brought challenges to an already burdened population. HUD determines what the Fair Market Rent for our area is each year as a guideline of allowable costs for rentals. The 2022 FMR for our area is \$873 for a two bedroom, and the average of what we are paying for rent is \$1200 for the same two-bedroom unit. Once the housing assistance provided through ESG CV is over, we will see an increase in evictions, thus creating another housing crisis. As it stands today, the recidivism rate for those becoming homeless when the housing assistance ended is 35%. The number of literally homeless individuals for 2022 in Columbia County is 208. This number has been slowly declining over the last few years, but is expected to rise again with the sunset of the CARES Act funds and the housing assistance that will no longer be available.

As our community faces this housing affordability crisis, one of the most important actions we can take to address that crisis is to build more affordable housing. At the core of a community is home, but that is out of reach for so many without bold, forward-thinking measures to increase affordable housing.
