

- RE: USDA RBEG Grant Amendment to Equipment Lease Agreement

On March 24, 2017, the USDA and Columbia County executed the closing documents for a \$76,850 USDA Rural Business Development Grant. The intent of the grant was to purchase training equipment for the Tri-County Aviation Academy "for the purpose of job training instruction related to potential employment.

During the application period for the grant and as a requirement of the application, the County and the Columbia County School District had entered into an Equipment Lease Agreement dated October 20, 2016 for the use of the training equipment. Since the execution of the Equipment Lease Agreement, the School District recognized a need to modify the list of equipment included in the lease to meet the current educational needs of the Academy.

USDA has reviewed this request and approved a modification of the RBEG grant to reflect this change. Staff has prepared and the County Attorney has reviewed the Amendment to Equipment Lease Agreement. The School District has placed the Amendment on the School District Board's agenda for approval in July.

We are requesting the Columbia County Board of County Commissioners approve the Amendment to Equipment Lease Agreement including Revised Exhibit A.

AMENDMENT TO EQUIPMENT LEASE AGREEMENT

THIS AGREEMENT is made this ______ day of ______, 20___, by and between COLUMBIA COUNTY FLORIDA, a Political Subdivision of the State of Florida, whose mailing address is P.O. Box 1529, Lake City Florida 32055-1529 (the "County") and the COLUMBIA COUNTY SCHOOL DISTRICT, whose mailing address is ______ (the "District").

RECITALS

WHEREAS, the County and the District entered into an Equipment Lease Agreement on October 20, 2016 for training equipment that the County would purchase using United States Department of Agriculture ("USDA") grant funds and lease to the District for use in training students and that the Equipment Lease Agreement included Exhibit A listing the training equipment; and

WHEREAS, the County has been awarded a Rural Business Development Grant ("RBDG") from the United States Department of Agriculture ("USDA") for the purchase of training modules as described on the attached Exhibit "A" (the "Equipment") for use exclusively by the District; limited to use by the Aviation Academy; and for the sole purpose of providing educational instruction or jobs training instruction related to potential employment or job advancements for adult students in accordance with section 4280.417(a)(2)(vi) of the Code of Federal Regulations;

WHEREAS, the District has recognized the need to modify the list of equipment included in Exhibit A and both the County and the USDA have reviewed and support the modification of said equipment; and

WHEREAS, the terms and conditions set forth in the Equipment Lease Agreement will remain the same and Exhibit A will be replaced with the attached revised Exhibit A.

NOW, THEREFORE, in consideration of the mutual covenants and conditions herein set forth, the parties accept the Revised Exhibit A as the list of equipment to be included in the Equipment Lease Agreement.
