**Discussion and Action Items**

1) City/County Consolidated 911 Dispatch

Representatives of the City, County and Sheriff's Office have been meeting to discuss consolidating 911 Dispatch. The two Fire Chiefs, the Lake City Police Chief, and the 911 Center Director have expressed support for consolidation of this service as a means to improve response time to emergencies. This item seeks the support of the full County Commission and the City Council for the consolidation efforts.

## 2) County Operated Animal Enforcement

Columbia County has committed to providing the enforcement of Animal Control "in-house" in fiscal year 2023-2024. This item would discuss any potential impacts of this decision on the City of Lake City.

Discussion was limited to an announcement by Commissioner Ford that the County would be interested in assisting the City with animal control through a mutual aid or Interlocal agreement.

## 3) Richardson Center Licensing Agreement

To discuss City and County operations at the Richardson Center and implementing the standard County Community Center agreement

MOTION by Commissioner Hollingsworth for the County to take ownership of the Richardson Center and Accept/Record the Deed. SECOND by Commissioner Williams. The motion carried 4-1 with Commissioner Murphy voting in opposition.

MOTION by Commissioner Williams that the County CO-Sponsor the grant with the City. SECOND by Commissioner Murphy. The motion carried unanimously.

City Councilman Todd Sampson said that the City allocated approximately \$50K for the City's recreation activities at Richardson for this Fiscal Year and may possibly offer as much as \$100K for the next Fiscal Year.
