RESOLUTION NO. 2023R-60

A RESOLUTION BY THE COLUMBIA COUNTY, FLORIDA BOARD OF COUNTY COMMISSIONERS, PURSUANT TO SECTION 18-77 OF THE COUNTY CODE OF ORDINANCES, ESTABLISHING A FEE SCHEDULE FOR ADMINISTRATIVE AND BOARDING FEES FOR THE IMPOUNDMENT OF ANIMALS BY COLUMBIA COUNTY ANIMAL ENFORCEMENT

WHEREAS, The Columbia County Board of County Commissioners, in the interest of public safety, has adopted by ordinance certain regulations for animal control and animal enforcement;

WHEREAS, section 18-77 of the County Code of Ordinances provides that "[w]hen any animal shall be impounded pursuant to this article, the animal control services provider shall collect from the owner thereof such administrative fees and daily boarding fees, as may, by resolution, be established by the board of county commissioners";

WHEREAS, Columbia County Animal Enforcement is the County's animal control services provider; and

WHEREAS, it is necessary for the Board of County Commissioners to provide for a schedule of fees not already provided by ordinance for the rendition of certain administrative and boarding functions to be offset in the form of fees charged to animal owners who wish to retrieve animals impounded by Columbia County Animal Enforcement.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Columbia County, Florida in regular session duly assembled this 19th day of October 2023 that the following schedule of fees is established as reasonable and appropriate amounts to be paid by owners for the offset of administrative and boarding costs incurred in connection with the impoundment of animals by Columbia County Animal Enforcement.
