1. Nature and purpose of agenda item:

The First Responder bonus from the State of Florida applied to all First Responders employed on June.16, 2023. The County issued bonus applied to County employees employed as of September 30, 2023. The Resolution excluded all firefighters as the County believed they received the State first responder bonus. However, the County has three firefighters that began employment on July 19, 2023 and did not receive either the State or County bonus. Each would have received a prorated bonus of \$500.

2. Recommended Motion/Action:

Amend Resolution 2023R-72 to state "Fire Rescue employees employed prior to June 17, 2023 receiving State Bonus checks are not eligible to receive the County bonus.

RESOLUTION THE BOARD **COUNTY** OF OF **COMMISSIOONERS OF COLUMBIA** COUNTY, RESOLUTION 2023R-72 **FLORIDA** AMENDING **AUTHORIZING A BONUS TO BE PAID TO EMPLOYEES** AND PROVIDING GUIDELINES

WHEREAS, the State of Florida has issued a First Responder bonus to all first responders employed in the State on June 19, 2023; and

WHEREAS, On December 21, 2023, the Board of County Commissioners adopted Resolution 2023R-72 which provided a bonus to current County employees who did not receive a first responder bonus from the State and who were in good standing and employed on or before September 30, 2023; and

WHEREAS, Resolution 2023R-72 explicitly excluded Fire and Rescue employees with the sole exception of the one civilian staff member with the understanding that the Fire Fighters were classified as First Responders and received a bonus from the State; and

WHEREAS, three firefighters were hired on July 19, 2023, after the State qualifying date and before the County qualifying date; they did not receive a first responder bonus from the State; and would have been eligible for a prorated bonus from the County; and

WHEREAS, The County Manager recommends the County provide a prorated bonus to these three firefighters;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF COLUMBIA COUNTY, FLORIDA, that it hereby approves a \$500.00 bonus to Jonathan Dowdy, Gregory Goolsby, and Kevin Pitman.

David and Kari-

First, I fully support the three listed individuals below receiving the prorated bonus. As Comptroller, I believe that the best course of action will be to add this request to the next board agenda, as an amendment to Resolution 2023R-72. This is because section 6 of the resolution states, "Fire Rescue employees are not eligible to receive the bonus". During the 12/21 meeting, CM Kraus added the "one change" to include the Fire/Recuse civilian employee to the list. There was then further discussion amongst the commission and I believe the intent was for everyone that did not receive a state bonus to be eligible for the county bonus. In an audit world, we have to go by what is on paper and I believe this quick fix will bring clarity and finality to the issue. Otherwise, you may have other departments making a similar case for payment to employees.
