RE:	Agenda item request to BOCC to accept State Emergency Communications Board Rural Grant to 24-10-04 to replace 911 Logging Recorders.

Via this memorandum, I am requesting to place on the November 7, 2024 agenda of the Board of County Commissioners, an agenda item, seeking approval to accept State Emergency Communications Board Rural Grant **24-10-04** in the amount of **\$99,042.12**. This grant, as with all State Emergency Communications Board Grants, are currently reimbursement grants that will require a budget amendment from the BOCC. Details of the grant request follow:

Request for permission to accept State ECB Rural grant in the amount of **\$99,042.12** for Columbia County, for the purchase and installation of a primary and secondary (backup) Eventide 911 logging recorder for our 911 system. Currently Columbia County utilizes 2 Equature logging recorders for our 911 CPE system. 1 is located at the primary PSAP and 1 is located at the Side B geo-diverse backup PSAP site at the Lake City Public Safety Building. The goal of this project is to replace both logging recorders with Eventide logging recorders capable of addressing the needs required for the ongoing INdigital Next Gen Core Services ESI Net digital data project. A complete quote and scope of work from Interaction Insight Corporation as well as the ECB Grant Award Letter for this project are attached as part of this request.
