RE: Mowing Maintenance

As you are aware, a research was conducted to seek pricing for mowing maintenance. Based on the calculated area associated with each listed category, pricing was concluded on current rates of FDOT contracts.

Landscape and Parks	\$ 94,500
Retention Ponds	\$120,316
Sidewalks	\$ 49,685
Guardrails	\$ 50,846
Urban Mowing	\$249,984

As requested, further research was conducted. After discussion with companies in this industry and with there being multiple categories of maintenance it would be in the best interest of the county to bid all inmate maintenance.

Therefore, I am suggesting two (2) options:

Option one (1) would be to bid by category

- Retention Ponds
- Sidewalks
- Guardrails
- Urban Mowing
- Landscape/ Lawn Maintenance

Option two (2) would be to bid the total package as a lump sum.

Please advise how you wish to proceed.

Mowing maintenance

Kevin on all this mowing that the inmates normally do as you are well aware it is scattered all over the entire county. I have talked with companies in this industry and we have multiple categories of maintenance but because of the logistics and diversity of the level of maintenance required we need to try and get the biggest bang of our buck and that's NOT always individual low bids. As you know mobility is a big issue and can drive cost up keeping crews busy or sending multiple contractors to the same areas. I would recommend we bid all inmate maintenance by categories with option or alternate lump sum contract for all work.

- 1-Retention Ponds
- 2-Guardrail maintenance
- 3-Sidewalk maintenance
- 4-Urban Mowing
- 5-Landscape/Lawn maintenance
- 6-Lump sum all categories total bid

There are companies that will bid total package and several that will only bid parts. Some of these categories have much different maintenance frequency and would not keep a crew steady but with the ability to schedule logistics of multiple categories as we did with the inmates makes the bid more inviting for better pricing from contractors in this industry. This process should be scored as such and not just take low bid on each line item as that creates multiple vendors to manage and doesn't always perform best maintenance practices. If a company bids entire package they should receive points for each category and be qualified contractors to perform necessary maintenance. Some of these areas are public use areas with playgrounds so said contractors would be required to provide national background checks for employees performing the work. Some of these areas will require proper MOT and signage so contractors would be responsible for that. Other areas require much more than just mowing and contractors will have to have Landscape experience to complete different properties. Some Retention areas will require occasional spray treatments it is my opinion this not be part of this bid as it will drive the prices up we need to continue this on an as needed basis with qualified contractors. Part of the bid should suggest contractors visit locations to be provided in bid package as no two locations are the same in any category. Before we bid this out we need to possibly reassign some of our full time staff to cover work areas and put some on bid package to better cover maintenance needs.

Kevin this is what I would recommend to the board on how to put this out with the thought of ultimately having one company perform this maintenance or worst case a couple companies handling a couple categories each. As a reminder we still have to oversee these contractors and the inmates where under Rick and I so this will need to be visited also so we are all on the same page as we all work and communicate well anyway. Please advise if we need to look at anything as I've tried to address the issues. The scope of work will be the challenging part getting ready for bid as this is not a cookie cutter at each location.

Attached you will find a copy of the current contract between Columbia County Board of County Commissioner and the Florida Department of Corrections, which states services they provide to the county. As you are aware, the Florida Department of Corrections has terminated their services due to Covid 19.

As a result, a research was conducted seek pricing for these services. Based on the calculated area associated with each listed property, pricing was constructed on the current rates of FDOT contracts.

Kevin the following information is based on the work that the inmate crews help perform across the county. With the list of properties after calculating area associated with each we applied pricing not only from local contractors but the current rates of DOT contracts. With that being said it is broke down by the different categories for which the work is performed.

Landscape and Parks94,500.00
Retention Ponds120,315.96
Sidewalks49,684.80
Guardrails50,846.40
Urban mowing249,983.96

Totaling-----565,331.12

These above totals is what it would approximately cost if the county bids out this work to be performed by contractors. Please keep in mind this work is scattered all over the county so additional cost could be seen to cover mobility that may or may not be considered in the pricing we used from current contracts that may be for a selected area. This was based on 12 visits for the year or once a month BUT as the discussion begins these visits would be based on growing season meaning more often April thru October than it would be November thru March.
