Minutes of **April 05, 2012**

The Board of County Commissioners met in a regularly scheduled meeting at the School Board Administration Office. The meeting opened at 7:00 p.m. with prayer. The Pledge of Allegiance to the Flag of the United States of America followed.

MOTION: By Commissioner Williams to adopt amended agenda. Second by Commissioner Bailey. The motion carried unanimously.

Public Comment:

Smoking at the Courthouse

Norma Pierce complained the public must breath **secondhand cigarette smoke** in order to access the courthouse annex. She asked that the problem be corrected, beginning with removing the ashtrays located at the sidewalks and doorway. She also reported the **entry door at the Lifestyle Enrichment Center** is extremely difficult for the seniors to use. Ms. Pierce was assured that there are plans in place to install the handicap door.

Supervisor of Elections Elizabeth Horne

Dominion Voting Systems - 30 Dominion ICE Ballot Scanning, and Custodial Needs

Ms. Horne discussed the need and options for replacing the old memory cards in the voting equipment prior to the upcoming election. She will have to have at least 35 cards, but requested funds to purchase a total of 70 cards so that there would be sufficient backup.

MOTION by Commissioner Williams to grant the funds necessary to purchase up to seventy (70) memory cards. Second by Commissioner DuPree. The motion carried unanimously.

Ms. Horne's office is in need of a custodian. The Board was asked to consider adding funds to that office to fund such a position and to continue furnishing the cleaning supplies. Two current employees of that office are interested in the position. The Board discussed with the Supervisor that employees already employed by the county must be paid overtime after they have worked forty hours. County Manager Williams will meet with Ms. Horne discuss the level of service needed and the best way to provide the service.

Building and Zoning by Brian Kepner

Public Hearing for Adoption:

<u>Text Amendment to Comprehensive Plan CPA 12-01 - County Commissioners</u>. This amends the five year schedule of capital improvements element of the Comprehensive Plan. The Planning and Zoning Board recommended approval. The public hearing opened and closed without public input.

MOTION by Commissioner Williams to adopt. Second by Commissioner Bailey. The motion carried unanimously.

Building Code Ordinance #No. 2012-2 (Public Hearing)

Attorney Feagle reviewed with the Board changes mandated by the legislature. The public hearing opened and closed.

MOTION by Commissioner DuPree to approve Building Code Ordinance #No. 2012-2. Second by Commissioner Williams. The motion carried unanimously.

Solid Waste Collection Franchise Enforcement Reported on by Attorney Feagle

It appears that WastePro and Veolia have resolved their differences consistent with what the County believes the exclusive franchise controls. At this time, there appears to be no conflict in the franchise.

Commissioner Williams reported there are two haulers operating illegally in the county who did not go through the proper channels to get approval to operate. He said the debris the two haulers are collecting is being hauled outside of Columbia County.

Handling options for the county would be to simply take the matter to county court, or to totally revamp Code Enforcement and have them handle the matter. Attorney Feagle advised that the quickest and simplest method is provided in Florida Statutes as an alternative enforcement method, and that is to have a citation issued to the violators. The issue of Code Enforcement will be taken up at the Special Meeting.

Bascom Norris Drive - Lowe's Property Offer

Attorney Feagle updated the Board on the status of the project. A notice was sent to Lowes' attorney this week making an offer (\$388,500) based on the appraisal received from the Columbia County Property Appraiser.

MOTION by Commissioner Williams to accept the appraisal amount. Second by Commissioner DuPree. The motion carried unanimously.

Economic Development Incentive Program Ordinance (No. 2012-1)

The ordinance was reviewed by Attorney Feagle. It has the capability of assisting local businesses and bringing in new businesses. The public hearing opened. Citizen Stewart Lilker offered input. The public hearing closed.

MOTION by Commissioner DePratter to adopt. Second by Commissioner Williams. The motion carried unanimously.

Skunkie Acres

Commissioner Williams explained that Skunkie Acres has become a nuisance. He explained that the smell it produces is horrible and offensive to those living in the area. Horses are being tied up on the county's right-of-way and are being allowed to graze there. Horse dung is being left on the road and road right-of-way and on residents' driveways. The horses are beating a trail on the county's right-of-way and simply causing a mess. He said that they have approximately 10-15 horses on a five acre tract of dirt. Commissioner Williams said that Skunkie Acres is a nuisance in the community and he wants to have them declared a nuisance. Commissioner Williams said that he plans to meet with Attorney Feagle on the matter and will bring the issue back to the Board for their support. He said that he wants to do whatever it takes to get this operation shut down.

Attorney Feagle said that he would research the options, but a lawsuit may be the answer. He said that state law addresses sanitary and nuisance issues and also health and safety concerns. Staff will meet with the Health Department to discuss launching an investigation on Skunkie Acres.

Bid Award 2012-B - Westside Community Center.

This item was pulled due to a declared conflict and a pending legal opinion. This item will be addressed at the next Board of County Commissioners meeting.

Rural Mowing Contract

Staff has met with the contractor regarding expediting the mowing cycle (from 35 days to 18 days.) Staff advised that the benefit received is simply not worth the additional cost, which would be an increase over all four mowing cycles of \$140,782.72. Staff recommendation was that the county not approve the idea of expediting the mowing cycle. There was no objection to staff recommendation.

Sheriff's Office - Replacement or Repair Generator

The generator at the Sheriff's Administration building located on U.S. Hwy. 90 East is aged and is malfunctioning. The least costly option would be to purchase parts for repair and arrange for a backup generator during repair (\$7,748 min.). The option of replacing the generator is estimated at \$28,685. It is the opinion of facility staff and the Sheriff that replacing the generator would be the best option. The County Manager recommended replacement.

MOTION by Commissioner Williams to replace. Second by Commissioner Bailey. The motion carried unanimously.

MOTION by Commissioner DuPree to declare the existing generator surplus and allow for sale on the open market. Second by Commissioner Bailey. The motion carried unanimously.

Special Meeting scheduled for Wednesday, April 11, 2012

The Board was asked to consider rescheduling the Special Meeting. Commissioner Frisina will not be able to attend on the scheduled date due to a mandatory requirement that she attend another meeting that was unforeseen. A tentative date of May 01, 2012 has been set.

MOTION by Commissioner DePratter to cancel and reschedule the meeting. Second by Commissioner Bailey. The motion carried unanimously.

MOTION by Commissioner Williams to approve the May 01 date contingent upon the room being available. Second by Commissioner DuPree. The motion carried unanimously.

Permission to Enter Private Property

Commissioner Williams asked to enter private property to correct damage caused by road water runoff. The Commissioner did not provide a name, but said it was the first house on the right when turning off of Chambria Way onto Queen Road.

MOTION by Commissioner Williams to approve. Second by Commissioner DuPree. The motion carried unanimously.
