MOTION by Commissioner Bailey to approve. Second by Commissioner Frisina. The motion carried unanimously.

Republic Service Inc. ("RSI")

RSI has requested Columbia County accept out of county waste disposal from Pilgrim's Pride located in Suwannee County. Specifically, the waste would be approximately 300 tons of Class I garbage at \$54 per ton and 20 tons of Class III garbage at \$37 per ton for a total approximate revenue of \$196,000 annually.

MOTION by Commissioner Nash to deny the request. Second by Commissioner Frisina. The motion carried unanimously.

National Fire Services

Staff discussed the need to authorize National Fire Services to conduct a 50 Year Drought Study for properties between 5 and 7 road miles from a Fire Station. The cost of this

study will be paid from the existing Fire Budget in the amount of \$17,400. Approval was requested.

MOTION by Commissioner Frisina to approve. Second by Commissioner Bailey. The motion carried unanimously.

Animal Control Services – Informational Item

The Lake City Humane Society will soon review the proposed contract between their organization and the County for animal control services. The contract proposes the County will allocate \$260,000 annually for three years.

Appreciation was expressed for the hard work and dedication that Commissioner Nash and Mr. Perley Richards, President of the Humane Society Board, put into resolving concerns between the agencies.

Tropical Storm Debby Reimbursement

Staff discussed with the Commission that Columbia County continues to struggle with the Division of Emergency Management ("DEM") over owed FEMA reimbursements relating to work projects performed during and after Tropical Storm Debby. CM Williams requested authorization to send a letter to Governor Scott explaining the situation and requesting his assistance in resolving the matter of unnecessary reimbursement delays.

MOTION by Commissioner Frisina to approve the request. Second by Commissioner Bailey. The motion carried unanimously.

County Budget Update

CM Williams gave a Power Point Presentation which addressed:

MOTION by Commissioner Nash to approve the concept of a percentage based budget agreement with the Columbia County Sheriff's Office. Second by Commissioner DePratter. The motion carried unanimously.

MOTION by Commissioner DePratter to authorize the inclusion of \$545,232 in the FY 14-15 Floor Budget to fund the operations of the Columbia County Sheriff's Office. Second by Commissioner Nash. The motion carried unanimously.

MOTION by Commissioner Bailey to authorize preparing the contact between the Board of County Commissioners and the Columbia County Sheriff's Office laying out the terms and conditions for a percentage based budget arrangement. Second by Commissioner Frisina. The motion carried unanimously.

MOTION by Commissioner Frisina to approve Budget Amendment #14-84, providing \$114,548 to the Sheriff's Office in 2013-2014 salary adjustments effective July 01, 2014. Second by Commissioner Nash. The motion carried unanimously.

The Commission discussed with CM Williams that other employees of the County, [besides the Sheriff's Office employees] need to have similar consideration. Chairman Williams reminded CM Williams that the Clerk's Office has taken a large hit the past few years and will also need to be given consideration.

Millage Rate

It was recommended that there be no increase in the millage rate for the upcoming fiscal year.

MOTION by Commissioner DePratter to establish the maximum millage rate for FY 2014-2015 at the same millage levied for 2013-2014, which is 8.015. Second by Commissioner Bailey. The motion carried unanimously.

Detention Center Status

The Detention Center remains the responsibility of the Sheriff. CM Williams discussed with the Board the need to work with their legislative delegation and the Florida Association of Counties to put procedures in place for parties to opt out of managing the jail.

Ball Team's Request for Funding (Agenda Addition)

The Columbia 9-U All-Star Baseball Team has qualified to play in the regional games in West Palm Beach. The Board was asked to donate funds to help with the team's travel

expenditures.

MOTION by Commissioner Bailey to deny the request for funds. Second by Commissioner Nash. The motion carried unanimously.

Settlement Agreement (Agenda Addition)

In the case of Kurt Heinmuller vs. Rickey W. Smith; Columbia County case number 2011-360-CA. The Board's portion of the settlement will be to pay the deductible (\$10,000). A copy of that Mediation Settlement Agreement is attached to the original minutes.

MOTION by Commissioner Bailey to pay the deductible. Second by Commissioner Frisina. The motion carried unanimously.

Commissioner Comments

Skunkie Acres "SA" Update. At the request of Commissioner Williams, SM Kraus provided an update on Skunkie Acres. Staff has met with regulatory agencies that have been involved with the complaints filed against SA to get a better understanding of the issues. While there has been some discussion that SA was considering a move to Texas, that move has not happened. SA is now considering other properties in the county that they may relocate on. The County continues to monitor the developments and will keep the Commission apprised.
