The meeting was called to order at 6:01 p.m. The invocation was given by Commissioner Williams, followed by the pledge of allegiance.

The meeting began with an address by Commissioner Williams to dispel rumors that the Richardson Community Center would be closed. He expressed that was not going to happen and the intention was to make sure that community center representatives attended meetings in order to have a quorum. Commissioner Nash stated that the purpose of the meeting was to ask community centers to create "wish lists" for their particular center. Penny Stanley stated that the Bethlehem Community Center was no longer under agreement with the Board of County Commissioners. More conversation followed but no action was taken.

**Community Center Reports:**

**Richardson Community Center-**

Zack Paulk expressed his gratitude for the improvements that have been completed at the Richardson Community Center and hopes to see additional improvements in the future. He mentioned the request to resurface of the basketball courts in the rear of the community center. This request includes lighting for the basketball courts and softball field. The fields would provide additional practice space for sports teams around the county. Mr. Paulk stated that he would follow up with city manager Wendell Johnson about the repaving of the parking lot. The RCC/AMN would like to request an outdoor sign similar to the signs currently at many of the other community centers.

Paulk also stated that the Sunshine Christian Basketball League would be returning to the Richardson Community Center for the State Tournament in March. Commissioner Nash asked

Mario Coppock to get together with Paulk on the bathrooms and resurfacing and he would follow up with Ben Scott and Clint Pittman on basketball resurfacing and lighting. He suggested that they get quotes and put numbers with their requests in order to prioritize projects.

Commissioner Williams suggested pursuing a grant that may help with the cost of the lighting. Coppock will follow up with Danny Sheldon from Musco Lighting to renew quotes.

**Springville Community Center-**

Mrs. Gloria McIntosh requested some playground equipment to add to the few pieces that they currently have. The equipment they have is around 50 years old. She would also like something done to the basketball court that is currently there. Commissioner Nash asked her to get her requests to Penny Stanley and they would be taken to the board.

**Westside Community Center-**

Penny Stanley was following up on the grant applied for to add a pavilion and basketball court. They already have the basketball goals but needs surface for the court. Commissioner Nash asked Penny to price out the amounts for the court and pavilion. He suggested that they get with Clint Pittman to discuss the surfacing. Mrs. Stanley stated that the center was creating a walking trail and just purchased an awning for the center from their funds.

**Deep Creek Community Center-**

Commissioner Williams stated that Deep Creek just completed a renovation to the center that nearly doubled the size of the building. He stated that the community center now requires payment for people to use the center regardless of the group. Deep Creek also has a non-regulation softball field for community use.

**Winfield Community Center-**

Commissioner Williams spoke on behalf of Rentz Gallooway and stated that they would be making improvements to the center but had funds to contribute to the improvements. Walking trail also needs to be reclaimed.

**Lulu Community Center-**

Mr. Coppock restated the Mr. Tommy Richardson asked for playground equipment at the community center.

**Other Comments:**

Commissioner Nash asked Penny Stanley to follow up with Lulu, Ft. White and Mason City for their community center concerns and "wish list".
