MOTION by Commissioner Frisina to approve the agenda. SECOND by Commissioner Williams. The motion carried unanimously.

#### **Ministerial Matters**

#### **Audit Presentation**

Richard Powell, CPA, gave a presentation on the results of the yearly audit and the annual financial report for the fiscal year ending September 30, 2015. A copy of that report is attached to the original minutes.

Commissioner Williams asked that the Board vote to accept the audit tonight and not to approve it through the consent agenda.

Discussion ensued. Consent item # 24 to be pulled for discussion.

Commissioner Nash asked CM Scott to present the audit again at the next meeting due to the presentation being unreadable on the screen.

#### (Final Hearings)

SD 0175 – Minor Subdivision Plat for Windswept Industrial Subdivision, Unit 3, Parcel ID 03120-000.

The public hearing opened and closed without comment.

MOTION by Commissioner Frisina to approve SD 0175 a minor subdivision plat. SECOND by Commissioner DePratter. The motion carried unanimously.

Z 0565 - Ordinance No. 2016-14 – To amend to Official Zoning Atlas by amending the preliminary development plan for an existing approved PRRD, The Oaks of Lake City. Tax parcels 09280-000, 09280-ALL LOTS, 09157-000, 09157-001, 09157-002, 03599-000 & 03608-000.

The public hearing opened and closed without comment.

Developer Brad Dicks addressed the Board. He requested direction on the rear entrance to the subdivision.

Discussion ensued.

Attorney Foreman recommended that the Commission approve the Ordinance with the caveat that Mr. Dicks' request that the Board go on record that the rear access will be permissible subject to an opinion from Attorney Foreman and County Planner Stubbs indicating that there is no requirement for a public hearing.

MOTION by Commissioner Frisina to take staff recommendation. SECOND by Commissioner Williams. The motion carried unanimously.

Staff recommended that this item be tabled until the July 21 meeting to allow time for the correction of the legal description.

MOTION by Commissioner DePratter to table this item until July 21. SECOND by Commissioner Frisina. The motion carried unanimously.

Chairman Nash asked if there were any items to be pulled from the consent agenda for discussion or clarification.

Commissioner DePratter restated that item # 24 was to be pulled.

Citizen Stewart Lilker requested items 1 & 15. CM Scott gave clarification on these items.

MOTION by Commissioner Frisina to approve the consent agenda with consent item # 24 pulled. SECOND by Commissioner Phillips. The motion carried unanimously.

MOTION by Commissioner Williams to adopt the consent agenda SECOND by Commissioner DePratter. The motion carried unanimously.

#### **Discussion and Action Items:**

#### Gleason Place Redevelopment Project

Economic Development Director, Glenn Hunter, stated that in early May the Economic Development Advisory Board approved a Economic Development Agreement with Hutton Development for the redevelopment of a parcel of land known as the old K-Mart Shopping Center. It was presented to the Board and the Commission requested that the agreement be restructured and brought before them at a later date.

Director Hunter introduced Kevin Jennings, a representative of Hutton Development.

Mr. Jennings presented the new proposal.

Citizen Waseem Khan spoke in favor of the project.

Mr. Steve Cronin of Suwannee County spoke in favor of the project.

Citizen Stewart Lilker stated that he is in favor of the project but he is against the county getting involved.

Discussion ensued.

CM Scott reminded the Commission about the agreement with the Sheriff for funding; he then informed the Commission that Sheriff Hunter has agreed to waive his portion of the taxes that would be due on this project.

The following changes to the agreement were agreed upon by the Commission:

- 85,000 square feet must be open and occupied to be eligible for the tax rebate for that year but could be cured the next year.
- Certificate of occupancy on 85,000 square feet by January 1, 2019.

Commissioner Williams stated that based on his comments and the changes that Attorney Foreman said would be in the agreement, he feels comfortable that we will only be rebating back what is generated; there is no burden on the County. There is no upfront money, there is no in-kind labor.

MOTION by Commissioner Williams to enter into an agreement . SECOND by Commissioner Frisina. The motion carried 3 to 2 with Commissioners Phillips and DePratter voting in opposition.

#### County Audit (former consent item #24)

CM Scott reminded the Commission that they were presented with the audit at the beginning of the meeting and recommended the Board accept the audit as presented.

MOTION by Commissioner Frisina to accept the audit as presented. SECOND by Commissioner DePratter. The motion carried unanimously

## Preliminary Non-Ad Valorem Assessment Rates for 2016-2017

CM Scott recommended the Board of County Commissioners set the Preliminary Non-Ad Valorem Assessment Rates at the current rates and direct staff to prepare the resolutions in preparation for the 2016-2017 fiscal year budget. The rates are attached to the original minutes.

Discussion ensued.

MOTION by Commissioner Williams to approve staff recommendation. SECOND by Commissioner Frisina. The motion carried unanimously.

#### **Open Public Comments:**

Citizen Sandra Buck-Camp requested more public transportation be made available and that the County provide property to house the vehicles.

Mr. Steve Cronin of Suwannee County stated that he owns a business in Columbia County and it is his opinion that if you have the shops that the people want, then they will shop here.

Citizen Stewart Lilker requested new meeting rules be adopted and offered comment on County Staff and ACM Kirby.

Citizen Ralph Kitchens stated that he would have rather seen a park on the old K-Mart property,
