Minutes of the Florida's Suwannee River Valley Marketing Group meeting held on <u>Wednesday</u>, <u>August 24, 2016</u>, 9:00 a.m., at the Hamilton County Tourist Development Council, 1153 US HWY 41 NW, Jasper, FL 32052.

Call to Order:

Greg Scott called the meeting to order at 9:06 a.m.

Welcome, Roll Call and Introductions:

Members present were: Greg Scott (SC), Teena Peavey (SOSMP), Paula Vann (CCTDC), Cody A. Gray (CCTDC), Rod Butler (Holiday Inn LC) and Jennifer Hand (HC). There were no members absent. A quorum was present. Partners present were Andrea Thomas (SFFCCSP), Amy Conyers (LBSSP), Jennifer Miller (SRWT), Elaine McGrath (SFFCCSP), Brenna Dacks (VF), Merrillee Jipson (Rum 138), Jimmy Johnson (Bienville), Megan Carter (HC), Serena Hastings (HC), Susan Ramsey (HC), Rhett Bullard (HC), Brittney Archer (SOSMP), Norma Tillman (HC), Willameese Tillman Adams (HC), Crissy Cribbs (FFSB HC), Helen Miller (Town of White Springs), Pam Cochran (HC), Mary McKenzie (FQT), Walter McKenzie (Town of White Springs), Stacey Tidwell (HC), Carol Walker (SOSMP), Sarah Benton (SOSMP) and Paulette Lord.

Approval of Minutes:

Teena Peavey asked some questions about a few charges to the FSRV Expense Account and Paula Vann answered her questions.

A motion was made, by Cody Gray, second by Paula Vann, to approve the meeting minutes as presented. **The motion was approved.**

Calendar of Events:

Cody Gray asked everyone to check to make sure they are receiving the calendar of events that is being sent out by email every month. He said if anyone is not receiving it or if an event is not listed on the calendar please let us know so that the email and/or the event can be added.

2017 Vacation Guide Bid:

Paula Vann introduced two options for the vacation guide bid. She said option one is the way we have traditionally always done the vacation guide bid. Paula said option two consists of doing the vacation guide by signing a three year contract with the company that wins the bid. She explained that in the past we have only had to send it out to local vendors, but by doing the three year contract we would have to put the bid out there to the public for everyone and their brother in the world to bid on, because it makes it above that threshold. Paula said it depends on how the board would like to proceed. Teena Peavey said every year we have to take a letter around to request funding (for FSRV) from the different counties and I'm not sure what the future holds for any county, but if we locked ourselves into a contract by signing the three year term and one of the counties decided to pull out what would be the issue with doing that? Teena said that's one of the concerns she has and she doesn't foresee that happening but you never know. Greg Scott explained that Suwannee County is going through some growth pains and we are trying to figure some things out and the one year plan would be a better option to make a decision one year at a time. He said once things get smoothed out and we all get headed in the same direction then maybe we can re-visit a three year option.

A motion was made, by Paula Vann, second by Cody Gray, to accept the option one bid for the vacation guide. <u>The</u> <u>motion was approved.</u>

DEO Grant 2017:

Paula Vann mentioned that she has emailed the letters for the 2017 DEO Grant. She said Columbia County has already approved the funding for FSRV's DEO Grant 2017. Greg Scott told Paula that Suwannee County has it in their proposed budget and they still have to approve that budget before the end of the year. Paula asked if Hamilton County has their letter. Jennifer Hand answered that the TDC for Hamilton County will propose the letter at their September meeting for Hamilton County. Paula explained to the group that in order to get the DEO funding for the next year (2017) everything has to be submitted by October or November at the latest. She talked about the DEO list for the next year. Paula went through the different items that are on the 2017 DEO list from previous discussions at other meetings. The group had a discussion on other projects they would like to add to the 2017 DEO list and will bring back before the board at the next meeting. Paula mentioned that after speaking with DEO, the \$50,000 portion that FSRV puts in could be used for things we do such as trade shows, promotional items, the website, the app and then the DEO grant portion could be used for hospitality staff training, our advertising and promotional.

Current DEO Grant:

Greg Scott went through each DEO project and the group discussed all the updates for each one.
