#### Agreement for Rail Spur

The Florida Department of Transportation ("FDOT") requires a Stipulation of Parties Agreement between FDOT, Weyerhaeuser NR Company and the Board of County Commissioners ("BOCC") before construction of the rail spur across Highway 90 at the North Florida Mega Industrial Park can begin.

# "How to DO Florida" Contract

How to do Florida is a half-hour television series that will feature Florida destinations. Staff recommends a sponsorship, the costs is \$24,225 and would include the following:

- One full episode with a total broadcast exposure of approximately 14-16 minutes
- Episode will feature one main activity and points of interest, all mutually agreed upon between SPONSOR and PRODUCER
- Viewers directed to PRODUCTION website for a detailed list of places producer visited and/or activities he did
- Includes lower-third with graphic of SPONSOR's URL in ending credits
- One rotating banner ad, which SPONSOR provides to the PRODUCER, will run throughout PRODUCTION site on all pages randomly from June, 2019-June, 2020
- All web ads will run from June 2019-June 2020 on howtodoflorida.com
- Destination URL and logo will be placed on howtodoflorida.com
- All raw b-roll footage filmed for the episode will be made available to SPONSOR (additional cost for drive, shipping & editing services do apply)
- SPONSOR will receive content licensing of episode for select platforms with approval of PRODUCER
- Episode will be placed on <u>howtodoflorida.com</u> as well as "Discover Florida" ROKU Channel

## Land Development Regulations ("LDR") Proposed Amendment

Staff presented two options for the changes to the LDR to allow recreational vehicles in an E8A zoning district and defining a campground and a campsite.

## Option 1:

Campground - A place, parcel, lot, or tract of land designed, designated, or intended to be occupied by tents, recreational vehicles, cabins, and/or campsites on a temporary basis.

Campsite - An individual area within a campground intended to be occupied by a camping unit or units under the control of a camper.

#### Option 2:

Revise the proposed draft language to exclude cabins in an ESA Zone District.

Discussion ensued.

MOTION by Commissioner DePratter to approve Option 2. SECOND by Commissioner Williams.

Discussion ensued.

The Chairman called for the vote. The motion carried unanimously.
