#### **RESOLUTION NO. 2023R-45**

## A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS FOR COLUMBIA COUNTY, FLORIDA, CREATING VOTING PRECINCTS PURSUANT TO FLORIDA STATUTES SECTION 101.001

WHEREAS, pursuant to Florida Statutes section 101.001, "upon recommendation and approval of the supervisor" of elections the Columbia County Board of County Commissioners, "shall alter or create precincts for voting in the county";

WHEREAS, Florida Law requires that each precinct be numbered and composed of contiguous and compact areas, and the supervisor is responsible for designating a polling place at a suitable location within each precinct;

**WHEREAS**, the precincts established by the board of county commissioners pursuant to section 101.001 shall not be changed except with the consent of the supervisor and a majority of the members of the board; and

**WHEREAS,** the Supervisor of Elections has presented a proposed map for such precincts for the 2024 Elections to be located across Columbia County which appears to comply with the requirements set forth herein and of section 101.001, Florida Statutes, and a copy of that proposed map is attached hereto as Exhibit "A";

**NOW, THEREFORE,** be it resolved by the Board of County Commissioners of Columbia County, Florida, as follows:

- 1. The Precinct Map attached hereto as Exhibit "A" as recommended and approved by the Supervisor of Election is hereby approved for the 2024 Elections, inclusive of all federal, state, and local elections and primary elections.
- 2. The precincts set forth on the Precinct Map are hereby created pursuant to Florida Statutes section 101.001.
- 3. The Supervisor of Elections shall conduct the 2024 elections and each election hereafter in accordance with this approval unless and until the same may be altered by a majority of this board with the consent of the Supervisor of Elections.
  - 4. This resolution is effective as of its date of adoption, August 3, 2023.
